You may nominate your own contractor to carry out this work. However, the contractor must be approved and accredited by the Roads Service, in accordance with the New Roads and Street Works Act 1991. If you choose to nominate the Council Roads Services as your approved contractor, you should call the switchboard and ask for the Roads Maintenance Section. The Roads Services' charge for a standard 3 metre dropped kerb is approximately £960 plus VAT. Actual charges are shown below.

You should note that you must make contact with East Dunbartonshire Council's Planning Department to confirm if planning permission is required for any works which you intend to carry out within the boundaries of your property.
