#### STEP 2 – CONTEXT AND DESCRIPTION OF THE PLAN

#### Context of the Plan:

A Parking Strategy for East Dunbartonshire will incorporate parking legislation outlined in the Transport (Scotland) Bill as well as set out high level policies for the control and enforcement of parking in line with East Dunbartonshire's Local Transport Strategy (LTS) Transport Planning Objectives (TPOs) and other statutory legislation. It is intended that policies contained within the Strategy will be directly from and contribute to LTS TPOs.

#### **Description of the Plan:**

Overall, the Strategy will ensure that the Council's approach to parking across the whole of East Dunbartonshire can contribute towards the delivery of EDC's LTS TPOs. The Strategy will also provide a rationale for parking-related decision making in order to enhance coordination of parking matters across Council services. It is intended that the Strategy will also contribute to a more strategic approach to the development of Decriminalised Parking Enforcement and support a rationale for Traffic Regulation Orders.

The proposed objectives are to:

- Develop parking policies derived from LTS TPOs on a wide variety of parking topics.
- Provide a consistent approach to parking across East Dunbartonshire
- Provide a strategy for the management of parking in town centres, residential areas, schools and stations/travel hubs
- Provide a strategy for the management of parking in specific locations e.g. Council estate / Southbank Campus, Kirk Road Car Park
- Provide a Council strategy for managing Transport Bill parking proposals
   / on street parking / street parking with bays
- Allow income generation to ensure DPE is sustainable
- Ensure parking is managed to provide enhanced safety for all road users

The Strategy will be accompanied by an Action Plan which will detail the actions the Council will take to implement the LTS TPOs and high level policies for the area and individual areas including in the LTS. This will include the development of future car parking plans and potentially Transport Regulation Orders that will be required.

It should be noted that proposed actions within the Parking Strategy will align with the TPOs.

What are the key components of the plan?

The Strategy is underpinned by the Transport Planning Objectives set out in East Dunbartonshire Council's Local Transport Strategy. This will largely define the Strategy's vision, although it is likely to contain its own set of objectives as outlined above. These are considered to be the key components of the Strategy.

Whilst the Screening process has identified that the Parking Strategy is likely to present environmental impacts to Population and Human Health, Air Quality, Climatic Factors and Material Assets, with the potential for significant effects, the Strategy will align with the Transport Planning Objectives (TPOs) of the Local Transport Strategy (LTS), which acts as the more strategic level document and has recently undergone a full SEA (consultation 17/09/19 to 12/11/19). Given that it is intended that the Strategy will align with the principles of the LTS, it has been concluded in line with the Environmental Assessment (Scotland) Act 2005 that a full SEA for East Dunbartonshire's Parking Strategy will not be required.

#### Environmental Assessment (Scotland) Act 2005 A Parking Strategy - Screening Report

Thank you for your Screening Report consultation which SEPA received via the Scottish Government SEA Gateway on 26 November 2019.

In accordance with Section 9(3) of the Environmental Assessment (Scotland) Act 2005 we have considered your screening report using the criteria set out in Schedule 2 for determining the likely significance of effects on the environment. Having reviewed the Screening Report, we consider that in respect of our main areas of interest (air, water, soil, human health, material assets (of which we have a specific interest in waste) and climatic factors) the Parking Strategy for East Dunbartonshire is unlikely to have significant environmental effects that have not already been subject to SEA. We note that the Transport Planning Objectives and the Local transport Strategy have been considered in previous SEA work. Although we are of the view that new significant environmental effects are not likely, it is for the East Dunbartonshire as Responsible Authority to make a formal determination taking into account the consultation responses received.

#### Screening Report

Thank you for your consultation which we received on 26 November 2019 about the above screening report. We have reviewed the screening report in our role as a Consultation Authority under the above Act, in accordance with the requirements of Section 9(3). In doing so we have used the criteria set out in Schedule 2 for determining the likely significance of the effects on the environment. Please note that our view is based on main area of interest for the historic environment.

Our understanding is that this strategy will set objectives and actions for parking in order to deliver the Transport Planning Objectives from East Dunbartonshire's Local Transport Strategy (LTS).

We welcome the screening exercise that has been carried out on the proposed objectives of the strategy but would note the commentary does not match the ticks in the matrix. We have assumed that the commentary is correct in that the environmental factors that have been identified as having the potential for being impacted upon are Population and Human Health, Air Quality, Climatic Factors and Material Assets (not Cultural Heritage as indicated in the matrix).

We note from the report that you consider that, as the proposed objectives and actions align with the Local Transport Strategy (which was subject to environmental assessment) the strategy in itself is unlikely to have significant effects on the environment that have not been assessed as part of the LTS. In light of this and the information contained within the screening report we are content to agree that significant effects on the historic environment are unlikely.
