Background

The Council Tax due on a property may be discounted or made exempt to reflect the personal circumstances of the adult residents. For the purpose of this reduction, adults who fulfill one of the following requirements shall be disregarded when counting the number of adults in the house. If all adults meet one of the following requirements then an exemption will be awarded.

1. A person taking a full time specified course of education at a UK University or Further Education Establishment which lasts for at least 24 weeks within each academic year and where the period of study consists of, at least, 21 hours per week.
2. A person, aged under 20, taking a qualifying course of education at an educational establishment where the period of study exceeds, at least, 12 hours per week and the course taken is not as a consequence of an office or employment held, nor arranged under any of the youth training schemes.
3. A person registered with the British Council and working as a foreign language assistant at a school or other educational institution in Great Britain.

In order to claim a discount/exemption, please complete Section 1, ask the Educational Establishment to complete Section 2 where applicable, sign the declaration on Page 2 and return the form to the address at the bottom of the page along with the appropriate supporting documentation.
