

Objections and representations should be made in accordance with the following provisions, namely:-		
1.	Any objection or representation relating to an application for a grant or renewal of a licence shall be entertained by the Council if,	
	but only if, the objection or representation:	
	(a) Is in writing;	
	(b) Specifies the ground of the objection or, as the case may be, the nature of the representation;	
	(c) Specifies the name and address of the person making it;	
	(d) Is signed by him or on his behalf;	
	(e) Was made to them within 28 days of this Notice being displayed as required by the Council.	
2.	Notwithstanding (1)(e) above, it shall be competent for a licensing authority to entertain an objection or representation received by them before they take a final decision upon the application to which it relates if they are satisfied that there is sufficient reason why it was not made in the time required.	
3.	An objection or representation shall be made for the purposes of (1) above if it is delivered by hand within the time there specified to the licensing authority or posted (by registered or recorded delivery post) so that in the normal course of post it
