Salaries are paid four weekly and this can give rise to small differences in the actual payments made from one financial year to the next. The annual cost of the chauffeur service is £47,661.17 this includes other duties, including civic duties, undertaken on behalf of the Council.

All Members are paid allowances in respect of mileage, subsistence & telephone calls.

Elected members are provided with mobile phones for business purposes and any personal telephone costs incurred are reimbursed to the Council.

Councillors Mechan & Moir are the Council Representatives on GG&C NHS Board and SPT Board, respectively and receive a separate allowance from these bodies.
