4. COUNCIL TAX

In 2018/19 the Scottish Government allowed councils to raise Council Tax levels by up to 3% following a nine year Council Tax freeze. In 2019/20, Council were able to raise Council Tax by up to 4.79%. East Dunbartonshire Council raised Council Tax by 3% in 2018/19 and by 3.95% in 2019/20.

Given that the funding gap for delivering Council services identifies continued savings required for 2020/21, with a requirement to find an additional £31.8 million in savings over the coming four years, increasing Council Tax levels is one way of helping to bridge the gap.

A 3% increase in Council Tax will raise an additional £1.9 million.
