- 5. Applications to register to vote must reach the relevant Electoral Registration Officer by 12 midnight on **Monday 19 April 2021**. Applications can be made online: https://www.gov.uk/register-to-vote.
- 6. The £500 deposit can be paid by legal tender or by means of a banker's draft from a drawer which carries on business as a banker in the United Kingdom or a building society cheque or by debit/credit card.
- 7. Applications for postal votes must reach the relevant Electoral Registration Officer at the address below by 5pm on Tuesday 6 April 2021. Amendments or cancellations of postal votes must reach the relevant Electoral Registration Officer at the address below by 5pm on Tuesday 20 April 2021.
- 8. Applications to vote by proxy at this election must reach the relevant Electoral Registration Officer at the address below by 5pm on Tuesday 27 April 2021.
- 9. Applications to vote by emergency proxy at this election, i.e. made after the 27 April deadline on the grounds of; disability suffered after that deadline (or, for applicants who suffered a disability before the deadline, their disability meant that they could not reasonably have made an application in time), work/service reasons, following Scottish Government advice or the advice of a medical professional in relation to coronavirus, being detained in a hospital under the civil sections of the Mental Health (Care and Treatment) (Scotland) Act 2003 or for Scottish prisoners serving a sentence of 12 months or less,
