SEA Screening Determination Culture, Leisure and Sport Strategy 2025

Dear SEA Gateway and Consultation Authorities,

I refer to your email dated 8th of December 2025 outlining the responses from the Consultation Authorities to the Screening Report that was submitted on 10th November 2025 in relation to the proposed **Culture**, **Leisure** and **Sport Strategy 2025**.

The Consultation Authorities are in agreement with the Council that the Strategy is unlikely to have any significant environmental effects. On 13th December 2025 East Dunbartonshire Council made a determination under Section 8(1) of the Environmental Assessment (Scotland) Act 2005 that the Strategy is unlikely to have any significant environmental effects. Therefore, the Strategy will not be subject to a full Strategic Environmental Assessment and an Environmental Report will not be prepared alongside the document.

In accordance with Section 10 of the Act, a copy of the screening determination along with the Screening Report and Consultation Authority responses will be made available on request as well as on the Council website at Strategic Environmental Assessment - East Dunbartonshire Council. An advert will also be placed in the Kirkintilloch Herald and Milngavie and Bearsden Herald to publicise the screening determination.

STEP 2 – CONTEXT AND DESCRIPTION OF THE PLAN

Context of the Plan:

The updated Culture, Leisure and Sport Strategy (2026-2031) is being developed by East Dunbartonshire Leisure and Culture Trust (EDLCT). EDLCT is responsible for the operation, management and delivery of leisure and cultural services in the area, which aim to be of maximum benefit to the community and accessible to all across East Dunbartonshire. This updated Culture, Leisure and Sport Strategy (2026-2031) will help EDLCT with operational matters and provide a strategic direction for EDLCT in relation to culture, leisure and sport. An up-to-date strategy is also required to apply for external funding opportunities.

The previous Culture, Leisure and Sport Strategy (2015) was co-developed by EDLCT and East Dunbartonshire Council. The previous Strategy was initially developed in combination with the Sport Pitches Strategy before they were divided into two separate pieces of work. The final Culture, Leisure and Sport Strategy set out an operational approach to culture, leisure and sport in East Dunbartonshire, but also an action programme that included large scale asset projects. Due to the nature and scale of development projects in the action plan, the previous Culture, Leisure and Sport Strategy was subject to a full SEA.

The updated Strategy detailed in this report will focus only on operational matters and will not include large asset developments or a combined Sports Pitches Strategy — which was updated in 2024 (and screened separately for SEA requirements). Any potential future capital asset projects relating to culture, leisure as sport will be assessed individually at the planning and project level utilising the LDP policy framework and Development Management process.

Description of the Plan:

This high-level strategy will guide EDLCT's operation and management of leisure and cultural services throughout East Dunbartonshire. The strategy will also help set out strategic priorities for the next five years.

What are the key components of the plan?

The key components of the Strategy are intended to be:

Vision

The lives of East Dunbartonshire communities will be enriched by the provision of inclusive, accessible and affordable opportunities in arts, heritage, libraries, leisure, sport and physical activity.

Mission

We will work with people in our communities to ensure equitable access to relevant and sustainable services, which will support the health, wellbeing and quality of life of all those living in, working in or visiting East Dunbartonshire.

Objectives

1. Increasing Participation for all – To increase participation in culture, leisure, sport and physical activity for all residents and visitors of East Dunbartonshire in an inclusive and sustainable way.

- 2. Improving Physical / Mental Health and Well-being To improve health and wellbeing through culture, leisure, sport and physical activity enabling everyone in East Dunbartonshire to lead full and active lives.
- 3. **Developing People** To support and develop our employees and network of volunteers to deliver culture, leisure, sport and physical activity in East Dunbartonshire, and to enable all individuals to develop their talent, skills and confidence.
- 4. Maintaining the Quality of our existing Culture, Leisure and Sports (CLS) offer & maximising opportunities To improve existing services and maximise opportunities for providing new activities by incorporating latest environmental and design standards, ensuring that East Dunbartonshire has first class culture, leisure, sport and physical activity venues.



and sport venues. This approach could make existing venues more resilient to the impacts of climate change. However, any identified projects or infrastructure improvements will be dealt with through major assets and environmental issues considered at the project level through the design and planning stages in consultation with the Councils Sustainability Team.

Material Assets – The Strategy focuses on the operational and strategic approach to providing culture, leisure and sport at existing venues, which are considered material assets. The Strategy mainly focuses on the day-to-day and strategic approach to future operations which will have influence on how the current material assets are utilised.

Cultural Heritage – A main part of the Strategy is to promote and involve everyone in East Dunbartonshire in culture, leisure and sport. Wellbeing – both physical health and mental wellbeing from social inclusion – are potential impacts from promoting involvement in cultural activities. However, these impacts are also likely to be localised in terms of the significance.

Landscape – Similar to climatic factors, the strategy intends to set out the use of the latest environmental and design standards for improvement of services. This approach could change the landscaping of certain existing facilities and make them more resilient to the impacts of climate change (i.e. flood mitigation). However, there are no definitive plans for these projects in the Strategy as it just sets out the strategic approach for the future. Although asset projects are not a part of the Strategy action plan, any future developments of culture, leisure or sport related projects will be comprehensively assessed at the project level stage when proposal site come forward through the LDP site assessment and land allocation process and/or separate planning application process.

Inter-relationships issues – The Strategy is intended to be high-level with a limited scope, and it is unlikely to have significant effect on the other individual factors.

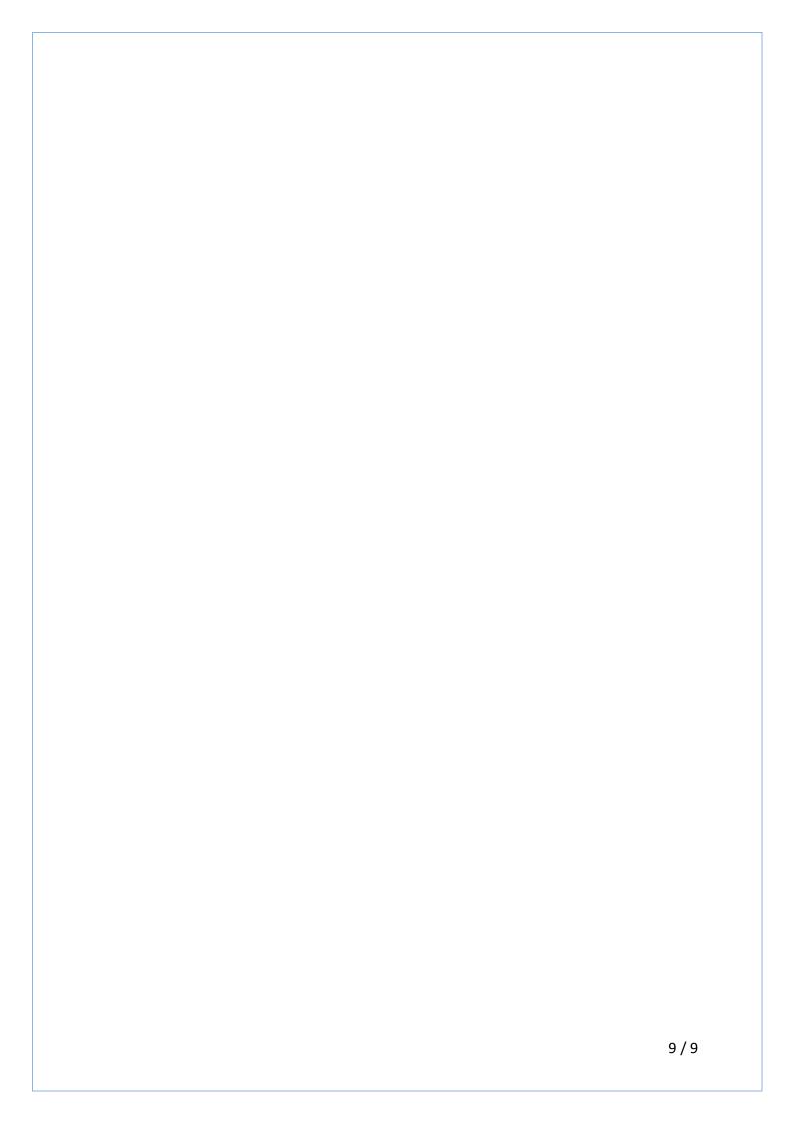
STEP 4 – STATEMENT OF THE FINDINGS OF THE SCREENING

Summary of interactions with the environment and statement of the findings of the Screening: (Including an outline of the likely significance of any interactions, positive or negative, and explanation of conclusion of the screening exercise.) As outlined in the initial components assessment above, there are no anticipated significant impacts on the environment from the proposed Strategy itself. The only impacts identified will be minor, localised and mostly positive in nature related to community cohesion, health and wellbeing.

Due to this Strategy being more of an operational PPS, and the action plan not setting a framework for projects/developments, it is not likely that there will be any significant environmental impacts. Any potential future development projects relating to culture, leisure and sport will have potential impacts reviewed separately through the LDP and planning process.

It is the Councils view that the overall environmental impacts of the Strategy are not likely to be significant. Therefore, it has been determined that, under Section 5(3) of the Environmental Assessment (Scotland) Act 2005, a full SEA is not required.

Thank you for consulting us on this screening report for the Culture, Leisure and Sport Strategy, which we received on 10 November 2025. We have reviewed this report in our role as a Consultation Authority under the above Act. This is in accordance with the requirements of Section 9(3). To do this we have used the criteria set out in Schedule 2 for determining the likely significance of the effects on the environment.

Our view

The screening report states that there are **unlikely** to be significant environmental effects for the historic environment. We **agree** with this assessment.


