1.0 Purpose

1.1 The purpose of this procedure manual is to clearly state the school start dates along with age for pupil to enter Education. It also details the number of hours a primary pupil and secondary pupil in entitled too each week along with earliest a pupil can leave Education.

2.0 Scope

2.1 This procedure manual applies to all pupils within all schools of East Dunbartonshire.

4.0 School Start Dates

4.1 The school year commences in August of each year. The specific date can vary year-to-year and is published on the Council Website following Committee approval.

Children who have attained the age of five years at that time, or who will have on or before the last day of February of the following year will be registered to commence Primary 1 (see PM 3/01 Admission of Pupils to Schools).

All other pupils will progress to the next year stage in the August as defined above.





5.0 Hours of Attendance at School

5.1 The hours of attendance per week for school pupils are currently 27.5 for secondary and 25 for primary.

6.0 School Leaving Dates

- 6.1 The school leaving dates for East Dunbartonshire follow the guidance from Scottish Government Leaving school: your options mygov.scot. They are as follows:
 - 31 May
 - First day of the Christmas festive holiday period

The exact date you can leave school in Scotland depends on when your 16th birthday is. If it's between 1 March and 30 September, you can leave school after 31 May of that year. If it's between 1 October and the end of February, you can leave at the start of the Christmas holidays in that school year.

When you leave school you can:

- go to <u>university</u>
- go to college
- get a job or work experience
- get an <u>apprenticeship</u>
- start a business
- join the <u>armed forces</u>
- have a <u>gap year</u> taking time out, normally a year, between school and whatever you want to do next

A pupil nearing school leaving age may transfer to an appropriate full-time further education course in advance of their normal leaving date. **This will require the prior approval of the Chief Education Officer**, having considered all aspects of the case (e.g. transport, free meals, etc.) and provided that:

- i. the pupil has completed four years of secondary education;
- ii. the course is a full-time one providing subjects approved by the Education Services;
- iii. the school can guarantee the pupils attendance and behaviour at college will be regularly monitored by the pupil's guidance teacher and that irregular attendance or troublesome behaviour will be reported to the Chief Education Officer; and
- iv. in view of the authority, the pupil, because of their circumstances, could benefit from such a placement.

NOTE

Head Teachers must forward full details of requests for pupils to attend appropriate full time further education courses in advance of their normal leaving dates to the Chief Education Officer by 31 May.
