Stay local to snap up gorgeous Christmas gifts

If you are looking to fill your stockings with unusual and gorgeous gifts, the popular Christmas Art & Craft exhibition at Kirkintilloch's Auld Kirk Museum is always worth a look.

As always, this year's exhibition has an interesting selection of unique gifts with a focus on sustainability. A wide range of craft work from both local and national craft makers will be for sale including handmade jewellery, ceramics, soaps, candles, woodwork and textiles.

A selection of artists who exhibited during the year – including Denise ChateauLoney, Tom Wilson, Geoff Foord and the Kelvin artists - have been invited back to give visitors a second chance to enjoy their work.

The exhibition continues until Thursday 19 December and opening hours are Tuesday to Saturday from 10am-1pm and 2-5pm.

Setting Rent Levels

All tenants are encouraged to give us their views when we are setting rent levels for the coming year. Tenants who have indicated they are willing to be contacted by email, please look out for a message in the coming weeks. A link to the consultation will be provided within these messages and the consultation end date. The consultation will also be advertised on the Council's social media platforms.

We will use the feedback gathered during the consultation to prepare a report for a meeting of the Council's Policy & Resources Committee in February 2025, at which Elected Members will decide the level of rent increase for Council tenants in the year 2025/26. We will then inform you what your new rent charge will be for 2025/26 at least four weeks in advance of any changes that may occur.



New build affordable homes in Bearsden



The Council has taken ownership of the first phase of new affordable homes at Thorn View in Bearsden. The new development has been built on land which was previously part of Bearsden Golf Club and has been developed by Robertson Homes Ltd.

As part of planning conditions for the wider housing development, a total of 20 new affordable homes are being provided to the Council over three phases. The first phase – which comprises eight cottage flats – welcomed its first happy tenants in September.

The next two phases are due to be completed by March 2025 and will include a range of one, two and three-bedroomed cottage flats and houses. The homes will be provided for accessible and general needs housing for social rent.

The development was made possible through the allocation of grant funding from the Scottish Government's Affordable Housing Supply Programme.

Introducing Any Day Lets

Currently, all Council tenant rents accounts and tenancies start on a Monday and when a tenant leaves a property, the termination or rent account end date is a Sunday, following the 28-day notice period.

In line with service improvement, the Council has introduced an 'Any day lets and any day terminations' procedure. This means that the processing of rents and tenancy start and end dates have changed from weekly to daily.

For current tenants, this will not have any impact on you until your tenancy ends.

It is the tenant's responsibility to ensure that your rent is paid either weekly, or monthly by agreement only. Remember, if you are paying your rent weekly, then this is due by close of business on a Friday. If you choose to pay monthly, then it is recommended that you set up a direct debit. You can decide what works best for you and please speak to your Housing Officer if you need advice or are struggling to pay your rent.

Condition Report

Inspections

East Dunbartonshire Council



East Dunbartonshire Council Operate a programme of works to carry out Electrical Installation Condition Report (EICR) Inspections of properties in our area.

MP

This is a legislative requirement for all Social Landlords to carry out an inspection on properties, every five years

We work in partnership with a contractor, MP Group to carry out the inspections on behalf of East Dunbartonshire Council.

What Happens:

- East Dunbartonshire Council will write to you, to advise you to contact MP Group, as your property will be due an Inspection
- MP Group will schedule you an appointment for an Inspector to visit your home to carry out an inspection
- MP Group Staff, will visit your home wearing Identification badges and visit on the scheduled date and time
- Inspections will take around 45 minutes
- · These Inspections are at no cost to the tenant

If you receive a letter, it is important that you contact MP Group, to schedule an appointment and allow access for the EICR Inspections to take place. If you do not respond to the letter or allow access you are in breach of your tenancy agreement and East Dunbartonshire Council will seek legal action

How are services performing?

Tenant Rent Arrears

The maximisation of rental income and pursuit of rent arrears continues to be a priority for the Housing Service. Housing Officers continue to provide advice and support to all tenants who engage; pre tenancy advice provided to new tenants on rent charges; and weekly Housing Officer availability at Kirkintilloch Jobcentre on a Tuesday morning for tenants in receipt of Universal Credit. Rent arrears escalation actions continue to be taken against tenants in serious and increasing rent arrears, which include the serving of Notice of Proceedings, a pre court requirement, legal action and eviction where appropriate.

Tenants are encouraged to engage with their Housing Officer for advice and assistance at earliest opportunity rather than allowing rent arrears to accrue. Chart 1: Current Tenant Rent Arrears per quarter



* Q3 (Oct-Dec) includes 1st week in January 2024 (week 40) which gives a truer reflection of arrears at that stage.

Rent Loss

The Housing Service continues to work closely with Property Maintenance to ensure properties are returned as fit to let as soon as possible. It is a priority to bring the rent loss figure down. Quarter 2 (July – September) has decreased by just over £15,000 compared to the previous Quarter 1 (April– June) and is shown in Table 1.

Void Property Turn Around

Re-let times have increased due to the number of longterm voids being returned to Housing for allocation over the last 3 quarters (January 2024 - September 2024). There has also been an increase in the number of buyback properties added to the Council's housing stock which has contributed to an increase in void numbers and extended void turnaround times. The Housing and Void Teams are working closely and meet monthly to ensure off charge and long-term void properties are monitored closely, with the aim that all void properties are returned as fit to let as quickly as possible close to target times.
