Summary of the PPS & Proposed PPS Objectives


The Sports Pitch Strategy for East Dunbartonshire has been proposed in order to ensure the longterm protection, improvement, development and management of playing pitch provision in the local area. The Strategy will focus on football, rugby and hockey pitches specifically. An audit of current pitch provision including those in school sites will be carried out to determine the quality, availability and accessibility of the pitches which will aid recommendations for improvements to pitches. It is intended that the Strategy will provide a framework for the delivery and implementation of sports facilities and will assist sport development and land use planning.

The proposed objectives and key drivers for the Strategy include:

- Improved asset management to ensure better quality pitch and changing accommodation provision;
- Effective and efficient management for the delivery of better managed pitch sites of outdoor sports facilities and use of resources;
- To integrate development planning for current and future pitch provision. This will identify any need for developer obligations where developments would create a direct need for particular facilities or place additional requirements on existing facilities;
- To ensure a more robust coordinated investment planning for pitch provision through partnership working, where appropriate,
- To determine the prioritisation of capital and revenue investment and the ability to secure external funding;
- To support sports development and encourage an active lifestyle through pitch sports;
- To improve and enhance current pitch provision;
- To promote community involvement and ownership in pitch site developments.

The intended outcomes of the Sports Pitches Strategy are as follows:

- A clear framework for outdoor sports pitch facilities providers, including the public, private and third sectors;
- Identifying sporting and sport facility needs, particularly focussing on particular local demand issues;
- Ensuring that pitches are in the best location to account for population changes and future housing development;
- Targeted improvements through developer obligations to create or improve pitches in ideal locations of the communities in East Dunbartonshire;
- Addressing issues of accessibility, quality, maintenance, management and booking facilities
- Identify potential sites for upgrading/enhancement;
- Prioritisation of investment, and consideration of potential strategic partnership developments, including approaches within the scope of the Community Empowerment Bill.

ENVIRONMENTAL ASSESSMENT (SCOTLAND) ACT 2005 East Dunbartonshire Council - Sport Pitch Strategy

Thank you for consulting Historic Scotland on the screening report for East Dunbartonshire Council's Sport Pitch Strategy, received by the Scottish Government's SEA Gateway on 6 March 2015. I have reviewed the screening report on behalf of Historic Scotland in its role as a Consultation Authority in accordance with Section 9(3) of the above Act. In doing so, I have used the criteria set out in schedule 2 for determining the likely significance of effects on the environment. Please note that our view is based on our main area of interest for the historic environment.

I understand that the Strategy will aim to provide a clear framework for the management and planning of planning pitch provision in the East Dunbartonshire area. You have noted that some pitches within the Antonine Wall World Heritage Site Buffer Zone, but that the Strategy will not have significant environmental effects on this designation, but that it will be taken into account in the development of the Strategy. You consider that the Strategy's effects will be minimal and localised in nature. On the basis of the information provided in the screening report, I am content to agree that the Strategy is unlikely to have significant effects on the historic environment.

However, as you will be aware, it is the responsibility of East Dunbartonshire Council as the Responsible Authority to determine whether the strategy requires an environmental assessment and to inform the Consultation Authorities accordingly. The Environmental Assessment (Scotland) Act 2005 East Dunbartonshire Council Sports Pitch Strategy

I refer to your screening consultation submitted on 06 March 2015 via the Scottish Government SEA Gateway in respect of the above draft plan.

In accordance with Section 9(3) of the Environmental Assessment (Scotland) Act 2005, SNH has considered your screening report using the criteria set out in Schedule 2 for determining the likely significance of effects on the environment.

Though the main focus is on improving (upgrading/enhancing) the existing resource, there may be a requirement to identify new sites for sports pitches which arises from this Strategy. However, on the basis of our understanding that the document does not extend to identifying particular new sites or options, we agree that the above Strategy in itself is not likely to have any significant environmental effects in natural heritage terms.

Please note that this consultation response provides a view solely on the potential for the plan or programme to have significant natural heritage effects. We cannot comment on whether or not the plan or programme meets other criteria determining the need for SEA as set out in the Act.

Environmental Assessment (Scotland) Act 2005 East Dunbartonshire Sports Pitch Strategy - Screening Report

Thank you for your Screening Report consultation which SEPA received via the Scottish Government SEA Gateway on 9 March 2015.

In accordance with Section 9(3) of the Environmental Assessment (Scotland) Act 2005 we have considered your screening report using the criteria set out in Schedule 2 for determining the likely significance of effects on the environment. Having reviewed the Screening Report, we consider that in respect of our main areas of interest (air, water, soil, human health, material assets (of which we have a specific interest in waste) and climatic factors) the strategy is unlikely to have significant environmental effects. Although we are of the view that significant environmental effects are not likely, it is for the East Dunbartonshire Council as Responsible Authority to make a formal determination taking into account the consultation responses received.

If it is formally determined that SEA *is* required, you will be aware that the next stage requires the Responsible Authority to consult the Consultation Authorities on the proposed scope and level of detail to be included within the Environmental Report. This can be undertaken through preparation of a concise Scoping Report. We would encourage you to use the scoping process to focus the assessment on those SEA issues upon which there are likely to be significant environmental effects, to outline the baseline information you consider as most relevant and explain your proposed method of assessment. To assist with this process we have produced Standing Advice for Responsible Authorities on Strategic Environmental Assessment (SEA) Scoping Consultations, which is available from www.sepa.org.uk/planning.

We are committed to providing early and focused advice and supporting continuous engagement and would therefore welcome the opportunity to meet with you and discuss these issues prior to the formal consultation.
